### 2022 Highlights

### OCTOBER: Workshop on 'Informal Judicial Institutions', Prague

The INFINITY team organised a workshop from 20 to 22 October 2022. Over 20 academics assembled in the magnificent rooms of the <u>CEELI institute</u>, the Villa Grébovka, in the heart of Prague.



The workshop was a key event of David Kosař's ERC Consolidator Grant on '<u>Informal Judicial</u> <u>Institutions: Invisible Determinants of Democratic Decay</u>' (2021–2026). The participants engaged with conceptual challenges as well as specific informal judicial institutions in 13 jurisdictions. The drafts of the articles presented at the workshop will be used as building blocks for a special issue of the <u>German Law Journal</u> later this year. Stay tuned!



#### **JUSTIN Working Papers & Commentaries**

In 2022 we published four **JUSTIN Working Papers**. The topics covered include <u>Comparative</u> <u>Court-Packing</u> (David Kosař & Katarína Šipulová, both Masaryk University), <u>Constitutional</u> <u>Dynamics of Multi-Level Governance in Hungary</u> (Attila Vincze, Masaryk University), (De)Judicialization of Politics in the Era of Populism</u> (Jan Petrov, The Queen's College, University of Oxford ) and <u>Judicial Independence</u> (David Kosař, Masaryk University, & Samuel Spáč, Masaryk University & Comenius University Bratislava).

In September we also launched a new type of online publication. In **JUSTIN Commentaries**, we aim to publish short reflections on various topics concerning judiciaries worldwide. We had the honour to begin the new series with a commentary on the <u>(In)dependence of judges</u> <u>in Romania</u> penned by Judge Dragos Călin. Judge Călin discussed a new category of dependent judges within an independent judiciary as a result of recent legislative changes in Romania.

#### **JUSTIN events**

**JUSTIN research seminars** create a platform to exchange and disseminate knowledge and to meet colleagues involved in judicial studies research from all over the world. In 2022 we organised several of them.

In May we welcomed *Michal Ovádek*, currently a researcher at University College London. Michal presented a paper on adopting machine learning techniques to assess whether it is possible correctly to attribute the authorship of individual paragraphs of judicial decisions and opinions to their respective authors (judges) of the Court of Justice of the European Union.

In May, *Michal Bobek*, judge of the Czech Supreme Administrative Court and former Advocate General at the European Court of Justice, examined the ECJ's and ECtHR's recent case law and discussed the rule of law crisis in Poland, Hungary and Romania. Patrick Leisure, our colleague from the Department of Constitutional Law and Political Science of Faculty of Law from Masaryk University, presented his piece on the ECtHR's cases involving schools and education. His paper explored the impact of this line of Strasbourg case law on human rights, arguing that case law targeting schools and education should be treated as a distinct category.

In October, we welcomed Jacopo Mazzuri, a PhD student in Public Law from the University of Florence. He presented his research on the role of the judiciary in the Italian constitutional system, with a specific focus on the special reference judicial self-governance and position of the public prosecutor, including the historic, comparative and supranational perspectives. Jacopo stayed at the Institute for two months as visiting researcher.

In November, *Puleo Leonardo*, a postdoctoral researcher from Université libre de Bruxelles, presented to JUSTIN his paper (co-authored with Ramona Coman) on judges' opposition to attacks on judicial independence in Hungary, Poland and Romania.

Finally, in December Max Steuer and Darina Malova (both from the Department of Political Science, Comenius University in Bratislava) presented their paper on "Illiberalism and Constitutional Design: The Slovak Case".

### The webinar on the Integration of Ukraine into the EU: Challenges & **Opportunities**

In June, Katarína Šipulová co-organised and co-moderated the online roundtable on the integration of Ukraine into the EU. The event was co-organised by the Judicial Studies Institute and Oxford Global Society, with the support of the European Consortium for Political Science and the Dietmar Rabich / Wikimedia Commons International Society of Public Law - CEE



Chapter. Six leading analysts and experts from around the world (Timothy Garton Ash, Maria Popova, Milada Vachudova, Catherine Barnard, Roman Petrov and Daniel Bilak) discussed the challenges and opportunities arising from Ukraine's potential accession to the EU. Participants examined a legal and political assessment of Ukraine's preparedness to join the EU, the repercussions which candidacy status could have for the future development of the European integration project, the EU defence policy and the ongoing war.



# International Workshop on European Law: 'The independence of the judiciary in Europe'

In November, Attila Vincze organised an **international workshop on judicial independence**. Under the supervision of Professor Thomas Jaeger and Associate Prof. Filip Křepelka, the participants explored and discussed the role of judicial independence in European law in different contexts, attacks on judicial independence and the mechanisms for defending it. The international students' workshop took place in Čejkovice, in co-operation with Masaryk University Brno and the University of Vienna and thanks to the financial assistance provided by AKTION Czech Republic – Austria.

### New members and team achievements



At the end of the year we welcomed a new team member, **Michal Kovalčík**. Michal is finishing his master's studies at the Faculty of Law, Masaryk University, and he focuses on the role of courts at the domestic as well as the European level, populism and democracy backsliding. He holds a bachelor's degree in political science at the Faculty of Social Studies, Masaryk University. During his studies, he worked as a student research assistant at

the Department of Constitutional Law and also at JUSTIN (supervised by David Kosař and Zuzana Vikarská). Besides that, he completed for a long-term internship at the Czech Constitutional Court (for Judge Kateřina Šimáčková) and the Supreme Administrative Court (for Judge Michal Bobek).

**David Kosař** received the <u>2022 MUNI Scientist Award</u> for his outstanding research results and significant achievements in the field of research. He won the award with Ladislav Vyhnánek for the publication, <u>'The Constitution of Czechia. A Contextual Analysis</u>' (Hart, 2021).



### JUSTIN and media visibility

JUSTIN team members actively present their work in the media and they are often invited to contribute to television, radio and newspapers as professional commentators.

**Samuel Spáč** was one of the guests of the Slovak talk show, <u>'Večera s Havranom'</u>, where he spoke about justice in the Slovak judiciary. He also appeared as a guest on a <u>podcast</u> by the judicial initiative 'For Open Justice (ZOJ)', where he spoke about Slovak judges and their options for expressing their opinions on social and political issues. **Marína Urbániková** commented several times on issues related to media studies and journalism. She participated in one of the <u>Prague debates</u> focused on the future of Czech Television. In the <u>'Rozpravy o</u>

<u>médiích' podcast</u> she discussed whether the Czech media are free and how they have changed since the Velvet Revolution. And at a <u>'Multimedia Day event'</u> of the Department of Media Studies and Journalism she spoke about political journalism, its development, its similarities to and differences from that in the Czech Republic and Slovakia. Marína also commented on

the system of financing Czech television as a public service medium in the print issue of Marketing & Media. She also joined the debate about Slovak public service media and the election of the new general director of the public-service broadcaster, RTVS. She spoke on this topic again as a guest on the podcast of Slovak newspaper SME. Attila Vincze commented in the Brazilian online magazine, Revista Crusoé, on the influence of courtpacking in Hungary and how it affected democracy and human rights. David Kosař gave an



interview to <u>ČTK – Czech News Agency</u> about President Zeman's appointment of a new head of the Constitutional Court before his presidential mandate expired.
