Foreword



As it may be quite difficult during these days to predict what is ahead of us in 2020, we would like to look back on the last year and share with you some of our achievements.

The Judicial Studies Institute (JUSTIN) celebrated its third birthday in 2019. Since its establishment, we have published many articles and books, and engaged with various topics. Nevertheless, the overarching goal of our work remains the same: to deliver a cutting-edge research in the fields of judicial studies, constitutional theory, comparative public law, general international law, asylum and migration law, and human rights law. Currently, our research covers a wide range of topics such as judicial independence, judicial accountability, public confidence in courts and judges, transparency of the judiciary, legitimacy of courts, legislative responses to the Strasbourg case law, references to the ECtHR's case law by domestic courts, and, more generally, domestic compliance with decisions of the European Court of Human Rights and UN human rights bodies. Moreover, in 2019 Dr. Ondřej Kadlec joined our team, which has strengthened JUSTIN's expertise in jurisprudence and constitutional theory. Ondřej has also been researching the role of Grand Chambers in the decision-making of European Supreme Courts, which has become a promising new research line for JUSTIN.

In 2019 we reached three core achievements. First, the project "The Rise of Judicial Self-Government: Changing the Architecture of Separation of Powers without an Architect" (JUDI-ARCH, 2016-2021, funded by the ERC) was evaluated by the ERC. Our progress was perceived very positively and we got the green light for moving into the second half of this project.

Second, we have finished our project "Beyond Compliance – Domestic Implementation of International Human Rights Case Law" (supported by the Grant Agency of the Czech Republic). The monograph entitled *Domestic Judicial Treatment of European Court of Human Rights – Beyond Compliance* has just been published by Routledge! This book presents unique empirical findings on how often, how and with what consequences domestic judges engage with the ECtHR's case law.

Third, we have published articles in the European Constitutional Law Review, Common Market Law Review, International & Comparative Law Quarterly, Human Rights Law Review, and other prestigious journals. One of our articles has even made it to a top-ten-reads of 2019.

2019 Highlights

April: ECPR Joint Sessions of Workshops

JUSTIN members attended the prestigious 2019 Joint Sessions of Workshops organised by the ECPR in Mons. Out of twenty-nine amazing workshops, we participated particularly actively in the workshop *Judicial Authority Under Pressure: Politicisation and Backlash against Courts in the Age of Populism*, co-convened by JUSTIN director David Kosař and Danis Naurin (PluriCourts Oslo). The workshop addressed two highly relevant topics related to the functioning of current democracies. The first topic reflected on the process of judicialisation of politics while the second dealt with the rise of populism (which is sometimes accompanied by the democratic backsliding). Within this workshop, two JUSTIN duos presented their research.



In their case study on the European Court of Human Rights, Nino Tsereteli and Hubert Smekal explained – by adopting the exit and voice framework – the conflicting tendencies of politicisation and judicialisation of politics.

Katarína Šipulová's and David Kosař's research focused on what processes and tools political leaders usually employ in order to change the composition of apex courts. As numerous examples of constitutional reforms are observable in this regard, they categorised them and

provided an overview of courtpacking strategies.

Subsequently, David and
Katarína evaluated the
safeguards and strategies,
which could be effective in
helping the affected judges to
withstand political pressure.



November: A Conference on Judicial Independence

The judicial branch of power in some countries has gained significant attention recently. The Visegrád Group is often in a spotlight in this regard. When speaking about judiciaries in V4 countries, one of the most discussed aspect is their independence vis-à-vis political pressures.

A conference addressing this topic took place at the Faculty of Social Studies, Masaryk University and it was organized by the International Institute of Political Science, the Department of Constitutional Law and Political Science (both at the Masaryk University) and Konrad-Adenauer-Stiftung. Our members could not miss this opportunity to present their latest research!





David Kosař and Katarína Šipulová presented a paper on court packing strategies. These strategies might not be very visible at first glance. However, on the other hand, court packing can significantly affect the way in which the courts, and whole judiciary in more general terms, operate.

As one of the conference's goals was to evaluate judicial independence in the Czech Republic from comparative perspective, a contribution on judicial independence in Slovakia was presented by Samuel Spáč.
