Foreword



The Judicial Studies Institute started life in September 2016 as a research hub at the Faculty of Law, Masaryk University, which delivers a cutting-edge research in the fields of judicial studies, human rights law, constitutional theory, and international public law.

Research at JUSTIN currently studies judicial independence, judicial accountability, public confidence in courts and judges, transparency of the judiciary, legitimacy of courts, legislative responses to the Strasbourg case law, references to the ECtHR's case law by domestic courts, and, more generally, domestic compliance with decisions of the European Court of Human Rights and UN human rights bodies. During the last year, a range of research areas investigated by the JUSTIN members has been extended, as we welcomed two new members, Madalina Moraru and Bríd Ní Ghráinne: Madalina focuses on the evolution of the EU administrative governance performance in times of crisis, while Bríd is interested in the establishment of the safe zones in armed conflicts. Madalina and Bríd also brought the migration and refugee law expertise into JUSTIN.

In 2018 we have reached two core achievements. Under the research project "The Rise of Judicial Self-Government: Changing the Architecture of Separation of Powers without an Architect" (JUDI-ARCH, 2016-2021, funded by the ERC) we published the Special Issue on Judicial Self-Governance in Europe, which analyses the ever-growing role of judicial councils and other forms of judicial self-governance. This issue (published by the German Law Journal as Vol. 19, No. 7) contains case studies that discuss judicial self-governance in 12 European jurisdictions as well horizontal articles that address the most vexing issues of court administration. The second major achievement of 2018 ties to the project "Beyond Compliance - Domestic Implementation of International Human Rights Case Law" (BeCom, 2016-2018, funded by the Czech Science Foundation). This project studied the impact of international human rights commitments on domestic politics and the Czech and Slovak legal systems. During the last year of the project, its investigators have published in the European Journal of International Law and Masaryk University Journal of Law and Technology.

September 2018: Conference: Law and Judicial Dialogue on the Return of Irregular Migrants from the European Union
