## **Foreword**



The Judicial Studies Institute started life in September 2016 as a research hub at the Faculty of Law, Masaryk University striving to bring significant results by examining the field of domestic courts, international tribunals, and other bodies taking part in the administration of courts.

Research at JUSTIN currently concerns judicial independence, judicial accountability, public confidence in courts and judges, transparency of the judiciary, legitimacy of courts, legislative responses to the Strasbourg case law, citation analysis, and domestic compliance with decisions of the European Court of Human Rights and UN human rights bodies.

JUSTIN is at the moment home to two major research projects: "The Rise of Judicial Self-Government: Changing the Architecture of Separation of Powers without an Architect" (JUDI-ARCH, 2016-2021, funded by the ERC), which focuses on the ever growing role of judicial councils and other forms of judicial self-government in a globalizing legal order, and "Beyond Compliance - Domestic Implementation of International Human Rights Case Law" (BeCom, 2016-2018, funded by the Czech Science Foundation), which studies the impact of international human rights commitments on domestic politics and the Czech and Slovak legal systems.

Moreover, JUSTIN members also participated in one minor project "Legislating from Strasbourg: How International Human Rights Law Influences Domestic Legislation" (LEGIS, 01-04/2017, funded by the Norway Grants and MŠMT ČR) whose main aim was to strengthen ties between JUSTIN and the PluriCourts research centre based at the Law Faculty of the University of Oslo.

Furthermore, JUSTIN has also had collaborative partnerships with the iCourts centre at the Faculty of Law of the University of Copenhagen, Bergen Faculty of Law, and Middlesex University London, School of Law.

During its lifetime, JUSTIN has organized one conference and three workshops, the most significant of which was the JUDI-ARCH workshop in October 2017, which saw prominent experts in selected European jurisdictions come to Prague to present their contributions on individual forms of judicial self-government.

# February 2017: Workshop: Legislating from Strasbourg: How International Human Rights Law Influences Domestic Legislation

During the workshop both teams presented theoretical and methodological frameworks of their research projects as well as individual substantive papers on the role of international and domestic courts in the modern political and social systems. # May 2017: Conference: Beyond Compliance: Implementation of the Case Law of International Human Rights Bodies - Challenges and Their Reflection in the Czech Republic and Slovakia



Taking place at the Faculty of Social Sciences, Masaryk University, conference zeroed in on the implementation of the case law of international human rights bodies and courts, and included prominent speakers such as judge Jiří Malenovský (Court of Justice of the European Union), Agent of the Government of the Czech Republic before the ECtHR Vít A. Schorm and Agent of the Government of the Slovak Republic before the ECtHR Marica Pirošíková.

The results of the BeCom project that were presented at the conference will be published as a book *Beyond Compliance – Implementace rozhodnutí mezinárodních lidskoprávních těles na národní úrovni* (fortcoming in 2018).

# October 2017: Workshop: The Rise of Judicial Self-Government in Europe: Changing the Architecture of Separation of Powers without an Architect (JUDI-ARCH)

Among the most important events of 2017 was the first JUDI-ARCH Workshop that we hosted at the CEELI Institute in Villa Grébovka, Prague in October. This workshop brought together experts on judicial councils and other forms of judicial self-government from key European jurisdictions, namely: Davide Paris, Bianca Gutan, Elaine Mak, Christoph Krenn, Markus Vašek, Anna Śledzińska-Simon, Betül Durmuş, Fabian Wittreck, and Stewart Cunningham.

The workshop aimed to discuss the most vexing issues regarding the judicial independence and other judicial virtues. The papers presented in Prague will be published collectively this year.





# November 2017: Workshop: Implementation of Human Rights Judgments and Decisions against the Czech Republic

On the occasion of the 10th anniversary of the ECtHR's Grand Chamber's judgment in D.H. v. Czech Republic concerning the Roma children segregation in the Czech primary schools JUSTIN co-organized a workshop on the "Implementation of Human Rights Judgments and Decisions against the Czech Republic". This workshop was organized jointly by JUSTIN (BeCom project) and Middlesex University London, School of Law (Human Rights Law Implementation Project) which was



represented by Alice Donald and Anne-Katrin Speck. The aim of the workshop was to discuss the legacy of the D.H. v. Czech Republic case and implementation of other ECtHR's leading cases against the Czech Republic.
