# **INFINITY: Informal Judicial Institutions: Invisible Determinants of Democratic Decay**

The <u>INFINITY project</u> has reached its midpoint, marked by the publication of a <u>Special Issue of</u> <u>the German Law Journal</u>, co-edited by **David Kosař** and **Katarína Šipulová**. This comprehensive volume on informal judicial institutions and practices in Europe, spanning over 360 pages, concludes the first work package and sheds light on the often-overlooked role of informality in judicial governance and decision-making. It features 19 articles, including an introduction, 13 case studies and cross-cutting contributions.

The team also cooperated with other international teams investigating the role of informality in the judiciary and patterns of democratic decay. This cooperation has led to two articles in the Law and Policy Special Issue named "<u>Global Perspectives on Judicial Politics and Democratic Backsliding</u>" (eds. Michael Dichio and Igor Logvinenko) and two chapters in the collection on "<u>Informality and Courts: Comparative Perspectives</u>" (eds. Björn Dressel, Raul Sanchez-Urribarri, and Alexander Stroh-Steckelberg).

# TRIIAL 2: Trust, Independence, Impartiality and Accountability of Legal professionals under the EU Charter

The <u>TRIIAL 2 project</u>, funded by the European Commission, aims to strengthen the capacity of judges, lawyers and prosecutors to address fundamental rights and rule of law issues. This is achieved through 12 online, hybrid and in-person training events fostering a transnational knowledge exchange and collaboration among justice professionals. The project improves their ability to navigate challenges related to judicial independence, impartiality and accountability.

To date, the project has included two visits to Barcelona and Budapest by **Ondřej Kadlec** and **Šimon Chvojka** from JUSTIN, contributing to knowledge exchange on judicial governance and the European rule of law. Ondřej participated in the <u>Training on Mutual Trust and Judicial</u>

Independence in the European Arrest Warrant (EAW) framework organised by the University of Pompeu Fabra in Barcelona in March. Also, in November, he joined online as one of the speakers for the <u>Training on Judicial Dialogue and Freedom of Expression of Lawyers</u>, organised online by the National Union of Bars of Romania (UNBR). Šimon, in turn, attended the <u>Training on Fundamental Rights and the Use of the Preliminary Reference Procedure</u>, organised in hybrid mode (in person and online) by Eötvös Loránd University (ELTE) in Budapest in October 2024.

As part of TRIIAL, JUSTIN is co-organising a <u>transnational hybrid workshop</u> on 27–28 February 2025, focused on judicial governance and the rule of law. The workshop will address modern challenges in judicial administration, including court digitalisation, communication strategies and the extrajudicial activities of judges. <u>Renowned experts</u> such as **Marta Cartabia**, **Kateřina Šimáčková**, **Kees Sterk**, **Zdeněk Kühn**, **Jaroslav Gwizdak**, **Petra Škvařilová-Pelzl**, **Dragoș Călin**, **David Kosař** and many others will lead lectures, case study discussions and roundtables, offering participants a collaborative platform on which to evaluate these issues in the light of European standards and case law.

### CoRe: Beyond Security: Role of Conflict in Resilience-Building

The CoRe project is defined as problem-oriented research on the relationship between resilience and conflict in Czech society, especially in relation to the unprecedented war situation in Ukraine and the contemporary climate, energy and migration crises. Three JUSTIN members are participating in this research endeavour. Within the project, **David Kosař is** conducting research on the project's work package, focusing on political polarisation and legitimacy crisis. David has researched how supreme courts communicate with various segments of society, and his article on the embedding strategies of European apex courts will soon appear in the German Law Journal. **Kateřina Ochodková**, working under the same package, has analysed recent changes in the assimilated mode of representation of the external electorate in the electoral system for the Czech Chamber of Deputies. **Lukáš Hamřík** concentrates under the work package on the role of conflict in the international context. Lukáš explores the role of Article 2 TEU in European Parliamentary debates on rule of law backsliding in the EU and political parties' responsiveness to those developments.

### **SELECTED RESEARCH VISIT & SEMINARS**

### **Daniel Bogéa's Research Visit to JUSTIN**

In May and June 2024, JUSTIN had the pleasure of hosting **Daniel Bogéa**, a visiting researcher and dual PhD candidate in Comparative Constitutional Law at UNSW Sydney and in Political Science at the Universidade de São Paulo. During his



stay in Brno, Daniel <u>presented</u> his paper, *Off-Bench Judicial Behavior: A Conceptual Framework* for Assessing the Role of Judges Beyond Courts, during our JUSTIN research seminar. His presentation sparked lively discussion among JUSTIN members and guests from the Department of Constitutional Law and Political Science.

#### Seminar with Mathias Moschel: Constitutional Judges

The JUSTIN team <u>hosted</u> **Mathias Moschel** from the <u>Central European University (CEU</u>), who introduced his upcoming OUP book, *Ex-Ministers as Constitutional Judges*. His presentation sparked a lively discussion, showcasing his expertise in comparative constitutional law, international human rights and non-discrimination law, with a focus on critical race theory and gender perspectives.

#### A Roundtable with Professor Eirik Holmøyvik

We were delighted to <u>host</u> Professor **Eirik Holmøyvik** from the University of Bergen for an insightful discussion on the "Venice Commission." As <u>a member</u> of this esteemed advisory body on constitutional law since 2016, Professor Holmøyvik has served as a rapporteur on opinions concerning constitutional reforms, electoral laws, courts and democratic institutions across member states. His invaluable insider knowledge provided a unique perspective, making the roundtable an engaging and enriching experience for all participants.



### **Exploring Connections: Network Analysis, Judicial Systems, and Beyond**

A <u>workshop</u> on the applications of network analysis provided valuable insights into our research on judges and judicial networks. Guided by our colleagues **Petr Ocelík** and **Lukáš Lehotský** from the <u>Department of International Relations and European Studies</u>, Faculty of Social Studies, Masaryk University, the discussion highlighted how network analysis uncovers patterns of collaboration and influence within judicial systems and beyond. Their insights enriched our ongoing field-work and offered fresh perspectives on how relationships and networks could shape judicial decision-making processes.

#### **Compliance Vulnerabilities with Veronika Fikfak**

We had the privilege of <u>hosting</u> **Veronika Fikfak**, Associate Professor of International Law at University College London (UCL), at JUSTIN for a thought-provoking research seminar. Veronika, the principal investigator of the ERC-funded project, <u>Human Rights Nudge</u>, and a recent recipient of an ERC Consolidator Grant, presented her paper *Compliance Vulnerabilities*. Her presentation sparked lively discussions on human rights, international norms and compliance, enriching the dialogue among our team, visitors and student assistants.

### Seminar with Mathieu Leloup & Dimitrios Spieker: Rethinking Primacy's Effects

The JUSTIN team virtually hosted **Mathieu Leloup** and **Dimitrios Spieker**, who presented their paper <u>Rethinking Primacy's Effects: On Creating, Avoiding and Filling Legal Vacuums in the National Legal System</u>. Their presentation explored the often-overlooked consequences of the principle of primacy in national legal orders, focusing on the steps domestic judges must take when national law conflicts with EU law. The discussion addressed the challenges of disapplying conflicting provisions, the risk of legal vacuums and the increasing need for judicial creativity in balancing primacy with domestic constitutional principles.

### Seminar with Mila Versteeg & Adam Chilton: Unamendability & Democracy

**Mila Versteeg** and her co-author **Adam Chilton** joined us in a hybrid format to present their paper *Do Constitutional Unamendability Rules Protect Democracy*? Their research examines whether constitutional eternity clauses and court-created unamendability doctrines safeguard democracy effectively. The presentation fostered a stimulating discussion on the implications of unamendability rules for constitutional stability and democratic resilience.

### Seminar with Mária Havelková & Samuel Spáč: Gender & Pro Bono

As part of our seminar series, our colleague **Samuel Spáč**, together with his co-author, **Mária Havelková**, <u>presented</u> their paper *Freedom to Volunteer: Differences between Men and Women Lawyers in Providing Pro Bono Legal Services*. Based on data from over 2,000 lawyers in California and Florida, their study shows that while women express stronger support for volunteering, they engage less in *pro bono* work due to greater family and workload constraints. The discussion highlighted structural barriers limiting women's autonomy in *pro bono* decision-making and the broader implications for access to justice.

### Seminar with Lucas Lixinski & Ayla Alves: Enforcing Human Rights Judgments

Lucas Lixinski and Ayla Alves joined us for an online seminar to present their paper *Domestic Implementation and Enforcement of Inter-American Court of Human Rights Judgments: A Call for Technique.* Their research shifts the focus from the broader impact of the Court's rulings to the technical challenges of enforcement in domestic jurisdictions. By mapping enforcement mechanisms across different countries, they highlight how procedural hurdles shape the realworld effectiveness of human rights law. The discussion underscored the need for strategic, technical approaches to ensure the judgments translate into tangible legal and social change.

### **Online Seminar with Paulina Milewska: SLAPPs and Judicial Independence**

**Paulina Milewska,** from the European University Institute, joined us for an online seminar to workshop her draft article on the application of SLAPPs (Strategic Lawsuits Against Public Participation) to cases against judges. The seminar explored how SLAPPs, used to silence judges, expose vulnerabilities in legal systems.

### **HIGHLIGHTED TEAM PARTICIPATION AT CONFERENCES**

The International Society of Public Law (ICON•S) held its annual conference, entitled "<u>The</u> <u>Future of Public Law: Resilience, Sustainability, and Artificial Intelligence</u>," in Madrid, Spain, from 8-10 July. The event drew over 2,000 participants, with <u>our institute well represented by</u> <u>several members</u>. JUSTIN members chaired and organised several panels on topics such as judicial resistance; judicial transparency; chief justices and democratic decline; separation of powers; actors of legal reasoning at the European Court of Justice; and so forth. The JUSTIN team also contributed many valuable presentations on informalities at courts (Katarína Šipulová, Samuel Spáč, David Kosař), judicial transparency (Michal Kovalčík), oral hearings (Patrick Leisure), structural rights (Mathieu Leloup) and the role of grand chambers (Ondřej Kadlec). Besides formal discussions, the conference revealed plenty of new insights and contacts, thanks to the rich informal programme. The icing on the cake of the conference was the prestigious <u>ICON-S Best Article Prize 2024</u> for the article on comparative court-packing written by our David Kosař and Katarína Šipulová.

In 2024, University College Dublin hosted the ECPR 2024 General Conference. As usual, JUSTIN <u>was very well represented</u> at the main event. The JUSTIN team, composed of **Katarína Šipulová**, **David Kosař**, **Lukáš Hamřík**, **Etienne Hanelt**, **Ondřej Kadlec** and **Hubert Smekal**, contributed to various ongoing debates within the ECPR Section on Law and Courts (co-chaired by Etienne). These include judicial governance and the perception of judicial councils' role in the separation of powers; the importance and role of grand chambers at the two European supranational courts (ECJ and ECtHR); the European Commission's approach to tackling democratic backsliding in the EU member states; and judicial leadership at the ECJ.



In September, **Attila Vincze** attended the annual international <u>conference of the New Europe</u> <u>College of Bucharest</u>, organised jointly with the Romanian Association of Constitutional Law (ARDC). The workshop addressed the connection between central models of the rule of law and specific preconditions and contexts. In the EU, the topic is particularly apposite 20 years after the so-called 'Big Bang Enlargement.' Attila contributed by reflecting on the pitfalls and inefficiencies of the conditionality mechanism of the rule of law.



**David Kosař** and **Patrick Casey Leisure** <u>represented the JUSTIN</u> team at the <u>International</u> <u>Political Science Association</u>'s Research Committee Interim Meeting on Comparative Judicial Studies, held at the University of Texas in Austin. David and Patrick both presented papers, David chaired a panel on constitutionalism, and both took part in fascinating debates on various issues of comparative judicial studies with a diverse group of conference participants from around the globe. Patrick received a U.S. National Science Foundation grant to attend the conference.



### **GOVERNMENT & POLICY CONSULTATION**

**Marína Urbániková** served as an expert in the <u>Working Group</u> of the Ministry of Culture of the Czech Republic on Public Service Media, which focused on amending the laws governing Czech Television and Czech Radio.

**David Kosař** is a member of the <u>Consultative Panel</u> of the Czech President for the Nomination of Judges to the Constitutional Court. He has actively participated in several panel meetings, contributing his expertise to the selection process. He is also a member of <u>The College of Experts</u> on the Enforcement of ECHR Judgments and for the Implementation of the Convention for the Protection of Human Rights. This advisory body supports the Government Commissioner for the Representation of the Czech Republic in front of the ECHR.

### **TEAM ACHIEVEMENTS**

### **MUNI Scientist award**

**Katarína Šipulová** and **David Kosař** were honoured with the prestigious <u>MUNI Scientist Award</u> for their outstanding academic achievement. They were recognised for their editorship of the Special Issue of the German Law Journal entitled <u>Informal Judicial Institutions—Invisible</u> <u>Determinants of Democratic Decay</u>. This accolade highlights their significant contribution to legal scholarship and underscores Masaryk University's commitment to promoting excellence in research.



### **ICON-S Best Article Prize 2024**

**David Kosař** and **Katarína Šipulová** received the notable <u>ICON-S Best Article Prize 2024</u> for their groundbreaking work, <u>*Comparative Court-Packing*</u>, published in the *International Journal of Constitutional Law*. The article provides a novel comparative perspective on court-packing, broadening its definition to encompass not only court expansion but also emptying and swapping strategies. This prestigious award highlights their exceptional contribution to advancing the field of constitutional law.

### Prestigious AEJMC Faculty Research Award 2024

Mauro Goyanes, Marína Urbániková and Borja Jordá received the distinguished AEJMC Third Place <u>Top Faculty Research Paper</u> Award at the Newspaper and Online News Division of the Association for Education in Journalism and Mass Communication. Their paper, *Artificial Intelligence (AI) in Journalism: How Trust in Media and Attitudes towards Journalists are Associated to Acceptance, Trust, Willingness to Pay, and Replacement of Human Journalists with AI,* was presented at the AEJMC conference in Philadelphia, USA.

#### **Re:constitution Fellowship Program**

In 2024, we were proud to witness two members of JUSTIN, **Etienne Hanelt** and **Katarína Šipulová**, being selected as <u>re:constitution Fellows for the 2024/25</u> academic year. The re:constitution program awards 15 fellowships annually to early-career academics and practitioners, supporting innovative projects that address critical issues related to the rule of law and democracy.

As part of this program, fellows undertake a pan-European mobility lasting from three to six months at leading research institutions or legal practice sites across the EU. The program facilitates collaboration with partners and host institutions, fostering cross-border exchange and innovation.

<u>Etienne's fellowship</u> will focus on the academic legitimation of authoritarian politics in Hungary. Not only has Orbán expelled the Central European University from Budapest and tightened political control over state universities, but his regime has heavily promoted its own academic institutions and thinktanks. Its role, however, remains an under-researched topic. Academic research in these institutions is neither free nor open-ended, but is motivated and directed to support the government's agenda by normalising and legitimating its positions. Yet we know very little about these institutions, who they are, how they work, or with what methods they co-opt academics.

<u>Katarína will examine</u> how judges in different judicial cultures understand concepts related to democracy (such as the separation of powers, limits to off-bench activities, travelling between branches, constraints on judicial independence, etc.). She will spend her mobility period at <u>the Centre</u> <u>for European Legal Studies, Faculty of Law, University of Cambridge</u>.

#### Max Gressly and Florian Fleck International Visiting Scholarship

**Marína Urbániková** was awarded the <u>Max Gressly and Florian Fleck International Visiting Scholarship</u> and spent two months at the Department of Communication and Media Research (DCM) at the University of Fribourg, Switzerland. During her time in Fribourg, she focused on media policy and regulation and worked on her forthcoming book about public service media.

### **Regional Recognition**

**David Kosař.** David was honoured with the prestigious <u>South Moravian Region Prize</u> for his exceptional contributions to constitutional scholarship.

### **Recognition in the Czech-Slovak Legal Competition**

Our student assistant, Adéla Dočkalová, came first in the <u>Czech-Slovak Legal Competition</u> in 2024. Adéla was recognised in the Legal Theory, Constitutional Law, and Human Rights category for her <u>work</u> <u>on electronic school reports</u> and their connection to the historical development of traditional schoolbooks. She explored how foster care in the Czech Republic often involves grandparents and why they may be more affected by the digital divide. Her research highlighted how some schools limited communication with caregivers by requiring the use of electronic platforms and offered examples of good practice from schools that provided offline alternatives.

### **JUSTIN WORKING PAPERS, CONFERENCES & PUBLICATIONS**

In 2024, we published four <u>JUSTIN Working</u> <u>Papers</u>, sharing the latest research with a global audience. If you have ideas or work to contribute, feel free to send your manuscript to <u>justin@law.muni.cz</u>.



**Mathieu Leloup** <u>examined</u> how supranational courts reshaped the separation of powers, constraining states' autonomy and imposing a new blueprint for checks and balances in a multilevel legal landscape.

**David Kosař and Katarína Šipulová** delved into the informal networks of Court Presidents in a <u>chapter</u> which appeared in the *Handbook on Judging and the Judiciary*. They argue that Court Presidents undertake dual tasks—enhancing efficiency and resisting political interference, yet potentially eroding judicial independence.

**Lukáš Hamřík** investigated the personalisation of post-Lisbon EU politics within the European Council and the Council of the European Union. His <u>analysis</u> reveals that while some politicians have gained more individual power, the collective prerogatives of member states remain intact.

**David Kosař** and **Katarína Šipulová** also <u>conceptualised</u> the roles of Court Presidents, explaining their complex interactions with various judicial actors, such as politicians and judges. They highlight the dual influence of Court Presidents, who can either act as bulwarks against democratic decay or use their powers to erode judicial independence.
